The **New Unionville & Western RR** is a 1/8 scale railroad on 40 acres, complete with grade crossings!

We will Depart from Lexington about 7:15am. The drive to 4450 N Stidd Lane, Bloomington is 180 miles, so we would arrive about 11am.

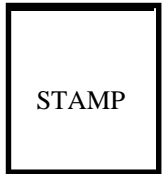
