REPORT ON THE NATIONAL CONVENTION

The 75th Anniversary convention of the NMRA met in Milwaukee, Wisconsin, July 11-18. Our organization was founded in 1935 (the year I was born) as was *Model Railroader* magazine. At that time there were no standards, and clubs discovered that they could not interchange equipment. The hobby has made tremendous progress in these 75 years, going from a time when

almost everything had to be scratch built to today's highly detailed, ready to run equipment with standards that benefits all.

The celebration was a time for a new logo and the *Scale Rails* magazine is changing its name to the *NMRA Magazine*. The initials NMRA now become the new brand, like NFL or NBA. Plans are under way to improve the website and put the photo library on line. One trustee reported at a session that the officers know that what we all want is more emphasis on divisions and regions. To that end a new handbook for regions and divisions is being developed. Nothing in it will be binding, but it will contain ideas and suggestions for us to use. There will be some minor changes in the structure of the organization. Since most of the important work is done by volunteers, there may be some expansion of offices to spread the workload more efficiently.

The convention followed its usual format with layout tours, clinics, and contests. I took a few photos of contest entries and will bring them to the October meeting. I saw some amazing modeling in the contest room. The judging is very strict, and some models that I thought were excellent got low scores.

I spent most of my time in clinics. I mainly went to clinics on scratchbuilding and operation. The first one I attended was on building an interlocking tower. The presenter took us through the process step by step, beginning with measuring the prototype

He said that if you know the size of a brick and the size of the wood siding, you can pretty much determine the dimensions of the building. The prototype was made more complicated by two later additions to the building, but these made it a more interesting structure. He showed the entire building process as well as how he developed the interior. One presenter said he liked scratchbuilding because he did not have to read instructions!

A second clinic on building craftsman kits was present by Andy Sperandeo, the Executive Editor of *Model Railroader*. His focus was on building resin freight car kits, which is one way to have unique rolling stock that you won't see on most layouts. Unfortunately, I learned that one of the major producers of resin kits, Westerfield, is going out of business.

Sam Swanson gave an excellent clinic called "Seven Simple Buildings." He took small buildings and made them look like contest quality structures. Fortunately, he will give that clinic for us at our October meeting. I highly recommend it. He has a good article on page 18 in the new issue of *NMRA Magazine*.

Witness & Clueless

There was a clinic on "Line Poles and Pole Lines" that showed how to add an important detail to a layout. Another was on "Taking Your Structures from Standard to Stellar."

Wayne Wesolowski makes very large scale models, including models of mansions, churches, government buildings, courthouses, and other notable structures. His basic method is resin casting. He did a great clinic on modeling tips from 50 years of experience. My favorite of his clinics, however, which I had attended before at another convention but wanted to see again, was on the Lincoln Funeral Train. He described the train, its travels from city to city where services were held in many places with large crowds, and the different locomotives that pulled it. Huge crowds gathered to see it go by, and at night they built bonfires so it could be seen. He then described how he built a large museum model of it, again using resin castings from his own masters.

Gerry Albers presented clinics on electronics, and I attended one called AC-DC-DCC. It was very clear and very interesting. He will present a clinic for us on signaling in the Spring.

Tony Koester presented a clinic on operation on his new Nickel Plate layout. Allen McClelland gave one on operation on his Virginian and Ohio railroad. Another presentation was on operation on a layout that modeled a switching area between Houston and Galveston, Texas. Bill Schaumburg, the editor of *Railroad Model Craftsman*, had clinic on commuter rail operation.

There were several other clinics on operation. Most groups use car cards, timetables and train orders, bills of lading, and other paperwork. Having spent most of my career burdened by paperwork, that element does not appeal to me even if it is prototypical. I like the simple switch lists that we use in Lexington operating sessions. One presenter said, "Operation is an extension of good modeling."

The most entertaining clinic I attended was on weathering locomotives with an airbrush. The presenter demonstrated his technique by weathering a Dr. Pepper can. He uses only four colors: Rust, Engine Black, Gray, and Roof Brown. He also weathered a small truck during the clinic. When asked if he weathered structures, he said, "Nothing goes on my layout until it is weathered!"

These are just examples of the many clinics available. There are three in the morning, three in the afternoon, and three in the evening. I have found that two out of every three works well for me.

There were a number of things for spouses to do. Sally went on a tour of three major churches and a synagogue, known for their unique architecture. One was built from material of the Chicago Post Office when it was demolished. Another was designed by Frank Lloyd Wright. A visit to the Milwaukee Art Museum was a real treat; it is a magnificent building.

It was a good convention; I learned a lot and brought home new ideas for my layout and a number of new items from the show.

The show featured some fine layouts and manufacturers' exhibits as well as dealers. The next convention will be in Sacramento, Calif.
